Meeting Review - President's Luncheon - LeMont, Pittsburgh - Dr. Steven Lacey

The event was held at The Energy Innovation Center in Pittsburgh on January 24. Thank you to the following members/guests that turned out for this event:

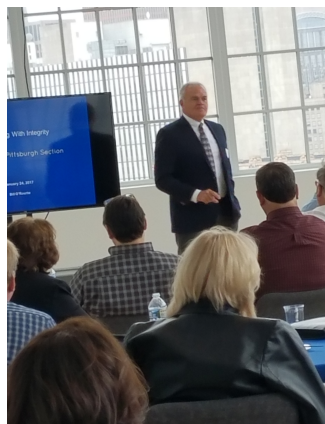

Joel M. Haight, Ph.D. PE., CIH, CSP has worked in the Industrial Engineering Department at the University of Pittsburgh since 2013.

He is currently the associate professor and program director for Safety Engineering within the Department. In the previous 33 years he served as Chief of the Human Factors Branch at the Centers for Disease Control and Prevention (CDC) - National Institute of Occupational Safety and Health (NIOSH) at their Pittsburgh Office of Mine Safety and Health Research, where he managed a research branch of 35-40 researchers in the areas of ergonomics, cognitive engineering, human behavior and training. Dr. Haight also served for nearly 10 years, as an Associate Professor of Energy and Mineral Engineering at the Pennsylvania State University. Dr. Haight worked as a manager and engineer for the Chevron Corporation for 18 years prior to joining the faculty at Penn State. His research interests include health and safety management systems intervention effectiveness measurement and optimization and human performance measurement in automated control system design.

He is the editor in chief and contributing author of Handbook

of Loss Prevention Engineering published by J.W. Wiley and Sons in 2013 and the Safety Professionals Handbook published by the American Society of Safety Engineers in 2012. In addition he has published nearly 60 refereed journal articles and conference proceedings.

Dr. Haight is an active member of ASSE, HFES, IIE and AIHA. He serves as the chair of the research committee for the American Society of Safety Engineers foundation and Board of Trustees member. He is a licensed professional engineer in Pennsylvania and Alabama and certified by the Board of Certified Safety Professionals and the American Board of Industrial Hygienists.



Deanna Kiska, Ph.D. is the new president of U.S. Micro-Solutions, Inc., an environmental microbiology laboratory founded in 1996 by her father, Herb Layman. Deanna received her Ph.D. in Microbiology from the Medical College of Virginia and completed a fellowship in clinical microbiology at the University of North Carolina-Chapel Hill. AIHA Press Release - U.S. Congress Permanently Overturns OSHA Recordkeeping Rule, Missing Opportunity to Protect Worker Safety & Health

Falls Church VA - March 24, 2017 - On March 22, while few were looking and with little debate, the U.S. Senate passed H.J.Res.83, which used the Congressional Review Act (CRA) to permanently overturn an OSHA final rule that clarifies the obligation of employers to establish and maintain accurate records of work-related injuries and illnesses throughout a five-year record retention timeframe. The legislation was previously passed by the House and now goes to the president, who is expected to sign it into law.

“Congress’ number-one priority should be protecting the American people; unfortunately, by sending this legislation to the president, they have placed them at greater risk,” said AIHA President Lawrence Sloan, CAE. “Better injury and illness recordkeeping leads to better, more targeted approaches to protecting worker health and safety. By quickly passing H.J.Res.83 with little public notice or debate, Congress missed an opportunity to fully explore the possible consequences of overturning OSHA’s recordkeeping rule. AIHA agrees with the need for regulatory reform; however, we hold that it should be done in such a way that allows the public and affected stakeholders to weigh in on its development.”

NIOSH Releases Sound App to Help Protect Workers From Hearing Loss

The [National Institute for Occupational Safety and Health](http://www.cdc.gov) has developed a new, free mobile application for iOS devices that measures sound levels in workplaces. The NIOSH Sound Level Meter app displays real-time noise exposure data based on NIOSH and OSHA limits. The easy-to-use app can be particularly helpful to occupational safety and health trainers as they teach construction apprentices about noise hazards and the need for hearing protection.

Hearing Protection Improves After Earplug Testing

Hearing protection among oil-rig workers improved significantly after they underwent testing for properly fitting earplugs, according to a new study by NIOSH. The researchers reported the findings of their study in the [International Journal of Audiology](http://www.cdc.gov).

In the workplace, hearing loss related to loud noise is a persistent problem worldwide. In the United States alone, loud noise exposes an estimated 22 million workers to hearing loss annually, according to information from the National Health and Nutrition Examination Survey. Although hearing loss is irreversible, the good news is that it is also preventable. To prevent work-related hearing loss, NIOSH recommends that noise exposure over an 8-hour day be under 85 decibels A-weighted (dBA).

In 2012 and 2013, NIOSH researchers traveled to Louisiana and Texas to test hearing protection devices (HPD) among 126 volunteer study participants employed as oil-rig inspectors and engineers. These workers face significant work-related noise from the helicopters that bring them to and from the offshore worksite. To test the level of protection afforded by the workers' earplugs, known as fit testing, they used the NIOSH-developed system HPD Well-Fit™. This simple system, which travels easily to field studies such as this one, involves having workers test their hearing with and without HPDs in their ears. The fit-test system measures the noise reduction provided by each worker's own earplugs. Before the fit testing, less than half of participants had adequate reduction in the noises they might experience on the job. After the testing, more than 85% had adequate protection. Individual fit testing can identify when earplugs do not fit a worker's ear canals and can help to train workers to effectively fit and wear earplugs.
