  - F. Mentoring – Several local section members have offered to serve as mentors. Matt Zock had taken the lead on pursuing mentorship possibilities with our area Universities (SRU, IUP, WVU). Appears to be little interest at this time.
  - G. SRU Student Section President Nick Ravotti graduating in Spring 2020. Newly elected president is Reece Leotta. Both thanked the Local Section for their support and look forward to continued interaction with AIHA. Through their recruitment efforts, and that of their faculty advisor Rona Smeak, SRU added 20 new members to their student section.
  - H. In addition, SRU was included among the top 10 values for Environmental Health and Safety in the US.
- IV. New Business:
- A. Several meeting attendees commented on the success of the Local Section virtual meetings held to this point and a few suggested continuing them even after the pandemic is over. Others expressed their desire to return to live meetings and suffering from “ZOOM fatigue”. Most attendees preferred attended live meetings with the possibility of recording or continued live streaming events if possible.
  - B. Laura Hallett suggested we make both our Zoom and live meetings more engaging with the use of virtual tours, games, round table discussions and new technologies. Any and all suggestions on how to do this are welcome.
  - C. Proposal for retired CIHs in our local section providing probono consulting services to underserved companies in the area. (RMU update).-Raffie Sessa and Frank Pokrywka along with Tom Blank and Fran Sehn continue to meet with Yvonne Van Hatsma from RMU and proposed conducting a course at their campus on Safety and Health for non-profit organizations in a 10 County area (approx. 8500 Organizations). This was initiated prior to the COVID shutdown that forced everything to online webinars. We are anticipating assembling and presenting this course in the spring as soon as arrangements can be worked out. Eventually our goal was to expand this to additional courses on EH&S topics of interest along with possible site visits by local section members to perform preliminary safety and health audits to assist these underserved non-profit agencies
  - D. Carl Heinlein discussed the importance of ABIH point approval for LS meetings and suggested calling on National AIHA staff to present on Government Affairs during the Biden Administration and the possible appointment of the new OSHA Undersecretary from the Pittsburgh area.

**Treasurer’s Report for the Executive Committee Meeting  
Wednesday, December 16, 2020**

1. Paula Sweitzer conducted and finalized the internal audit on August 6, 2020. No deficiencies were found, and an official Auditor’s Verification letter was received.
2. A \$1,000 check was sent to AIHF on December 2, 2020, for the AIHA Local Section Scholarship.
3. Because of the Pandemic, the Carnegie Science Fair was cancelled last year, and our sponsorship money has been carried over. This year’s Fair will take place **virtually**. Judging will take place via video conferencing on Wednesday, March 24 and the Awards Ceremony will be livestreamed on Thursday, March 25. No students or judges will be on-site at Carnegie Science Center. With the new virtual format, students will be able to enjoy additional programming on March 24 — including career conversations, interviews with STEM professionals, and engaging science videos — when they are not presenting to judges. Going virtual also makes the Fair more accessible to schools and students who traditionally may not have been able to participate in the competition due to travel constraints. Once more information is received, I’ll be sure to pass it along to the Committee.
