**Treasurer’s Report for AIHA Executive Committee Meeting  
Thursday July 12, 2018**

Our annual audit will be conducted shortly. An official Auditor’s Verification letter will be sent once completed.

In the fiscal year of 2018, we generated \$10,025.00 in revenue, and \$8,418.88 in expenses, giving us a bank balance of \$9,395.54, resulting in a net gain of \$1,606.12. Here’s the breakdown:
